## 1 **Objet et champ d'application**

L'annexe 3 fixe les métadonnées à utiliser par les profils d'intégration visés à l'annexe 5 ODEP-DFI, qui définissent l'échange de données médicales.

Pour chaque attribut de métadonnées, une liste contraignante et exhaustive de valeurs autorisées, c'est-à-dire un champ de valeurs (ci-dessous aussi « ensemble de valeurs ») est établie, le champ de valeur de chaque attribut étant référencé de manière univoque au moyen d'un identificateur d'objet (OID). Chaque valeur contenue dans un champ est définie de manière univoque à l'aide du code du système de code concerné, de l'OID du système de code correspondant et d'un terme.

Les métadonnées servant à échanger des données médicales sont notamment utilisées pour décrire les données médicales reproduites sur les interfaces utilisateurs des portails d'accès destinés aux pa-tients ou aux professionnels de la santé. Pour ce faire, il est nécessaire de traduire les termes dans les langues nationales. Les traductions sont gérées et publiées par eHealth Suisse sous la forme d'une liste de synonymes<sup>1</sup>.
